
Who We Are

DeKalb CSB charges for services based on income and family size, utilizing a sliding-fee scale for eligible clients. Revenues for fiscal year 2017 totaled \$34 million. In addition to fee revenue, the agency receives funding from DeKalb County and the Georgia Department of Behavioral Health and Developmental Disabilities.

Staffing

Nearly 500 dedicated and qualified staff represent DeKalb CSB including psychiatrists, clinical nurse specialists, registered nurses, licensed clinical social workers, case managers, licensed professional counselors, certified peer specialists, behavioral specialists, para-professionals and administrative support staff.

Governing Board

The members of DeKalb CSB's Board are appointed by the DeKalb County Board of Commissioners to fulfill our mission of providing the right service to the right person at the right time. Each board member is a DeKalb County resident who provides a unique perspective on mental health, developmental disabilities, and addiction diseases.
